DIAMOND LICENSE - EXCLUSIVE

Music producer (hereafter called LICENSOR) ensures that controls the mechanical rights and is the author of the musical work, INSTRUMENTAL / BEAT licensed herein, legally supported by the registration of copyright issued by the DNDA (National Directorate of Copyright) in Bogotá, Colombia. The entire composition, instrumentation, arrangements, harmony and melody of the INSTRUMENTAL / BEAT, was composed by the licensor **Kael Sounds** (Miguel Angel Grueso Villalba).

All the licenses purchased are not refundable and are non-transferable. THE LICENSOR prohibits expressly the resale or any other distribution of compositions of THE LICENSOR.

THE LICENSEE **MAY NOT**: sell, resell, borrow, rent, lease, assign, remix (make a mix), rearrange, delete: melodies, instruments, programming of battery, can't transfer acquired licenses or the rights to other person or third party (example: record, another producer (Man), another producer (Woman), another artist). This excludes companies that the licensee has to its name, at least 50% of the property.

MASTER USE - THE LICENSOR grants to THE LICENSEE an **EXCLUSIVE LICENSE** (in forward LICENSE) for record the vocal synchronization of its composition (letter of the song), partly or in its whole, and get as result a SONG.

MECHANICAL RIGHTS - THE LICENSOR grants THE LICENSEE an **EXCLUSIVE LICENSE** to use the SONG in: reproduction, duplication, manufacturing and distribution of CDs, DVDs, Blue-Ray, LP's, Cassettes, USB memories, digital downloads, digital recordings, audio and any known version thereof (collectively, the "RECORDINGS" and individually, a "RECORDING") around the world, for pressing or sale of a total of UNLIMITED copies of those recordings or any combination of such recordings with the status of a previous payment or economic value, of a sum of two hundred fifty dollars (US\$ 250), confirmed as received, according to the corresponding invoice for payment or document issued, certifying it. In addition, THE LICENSOR will allow THE LICENSEE to distribute UNLIMITED free internet downloads or, playback streaming for non and for profit, commercial and non-commercial uses. This license allows UNLIMITED payable reproductions of audio streaming, for sites such as: Spotify, Deezer, Google Play, Tidal, RDIO, Rhapsody, and any other platform streaming known or as yet unknown, but also applies to monetization of YOUTUBE. THE LICENSEE agrees that THE LICENSOR will receive 2% of all business profits received by this SONG.

PERFORMANCE RIGHTS / LIVE CONCERT - THE LICENSOR grants THE LICENSEE an **EXCLUSIVE LICENSE** to use the SONG in performances without and with the aim of profit, shows or concerts UNLIMITED. THE LICENSEE may receive compensation of all their actions with this license.

SYNCHRONIZATION RIGHTS - THE LICENSOR grants UNLIMITED synchronization rights for music videos of the SONG in video streaming platforms online (Youtube, Vimeo, Dailymotion, Facebook Video, etc.) reproductions WITHOUT LIMIT in all mentioned sites. For distribution of the song in television, cinema, video games, backgrounds or specific media, you will need to purchase a new license of synchronization independent, especially for these cases. BROADCAST RIGHTS - THE LICENSOR grants THE LICENSEE an **EXCLUSIVE LICENSE** to use the SONG, and issuing it in an UNLIMITED number of radio stations.

CREDIT - THE LICENSEE shall recognize the original authorship of the BEAT / INSTRUMENTAL appropriately and reasonably, in all formats of physical media, virtual, of communication and exposure known and as yet unknown, partial (Previews) or full (SONG) with the label "Produced by Kael Sounds" or "Prod."By Kael Sounds" vocally, and in writing whenever possible.

DELIVERY - At the time of purchase, THE LICENSEE will receive: 1 file. WAV 48 kHz / 16 Bit resolution mastered to - 1dB to give space to the voice, free tags, 1 MP3 file, Audio STEMS separated in these formats .WAV 48 kHz / 32 Bit floating to - 8dB to mixture, compressed format .rar, 1 PDF document mentioning the

type of LICENSE you have acquired, explaining the rights of use and the TERMS AND CONDITIONS (this document), and an invoice, indicating the details of purchase.

The entire package will be sent by an ascent platform to the cloud: Dropbox, Google Drive, Wetransfer, and Mega.

THE LICENSEE understands that this BEAT / INSTRUMENTAL could have be licensed to more than one person at the same time until the acquisition of this **EXCLUSIVE LICENSE**. Once a BEAT /INSTRUMENTAL has been sold with exclusive rights, it will not be available for any type of license and granting of the same, except, as explained in the clause TERM hereof. Licenses that have been purchased before the BEAT / INSTRUMENTAL license exclusively, shall not be affected and will remain valid until it reaches the number of sales or streaming stipulated in the clause MECHANICAL RIGHTS. THE LICENSEE understands that purchase this **EXCLUSIVE LICENSE** about the BEAT, does not give any administrative right to take legal actions against the other owners of non-exclusive licenses issued on the same, or any other composition performed by THE LICENSOR.

COMPENSATION – THE LICENSEE agrees to indemnify and hold harmless from any loss, damage, cost, expense, including without limitation, attorney fees, or any other partial or total derivative corresponding to claimed breach of any of the parties, belonging to warranties and/or agreements stipulated by THE LICENSEE in this document.

AUDIO SAMPLES – samples of third-party authorization, understood: Instrumentation VST, libraries, samples of audio, among others, is the responsibility of THE LICENSOR.

MISCELLANEOUS PROVISIONS – This license is not transferable and is limited to the specified composition, is a full agreement between THE LICENSOR and THE LICENSEE concerning the composition and shall be binding upon both THE LICENSOR and THE LICENSEE as to their respective successors, assigns or legal representatives.

LAW AND GOVERNMENT – This license shall be governed by and construed under the laws of the courts and tribunals of Bogotá, Colombia, regardless of the conflicts of legal principles thereof.

TERM – The term, both THE LICENSOR and THE LICENSEE, will be effective in all its provisions from the date of purchase of this license. It will take effect from this day, and will end up exactly once fulfilled the time considered by law of international copyright from this date. At the time this term comes to an end, THE LICENSEE will have to acquire a new license, otherwise not entitled to continue using the instrumental, the corresponding due to copyrights of THE LICENSOR.

PROMOTION – THE LICENSEE may share the MASTER RECORDING with us to give more promotion through our social networks, sending the link of the song to contacto@kaelsounds.com.co. We do not guarantee and we do nor force ourselves to share material, if this does not meet minimum quality technical and vocal standards.

PUBLISHING – THE LICENSOR grants THE LICENSEE the 50% of publishing rights. THE LICENSOR maintains ALL publishing rights on the instrumental, understand 100% of copyright and ownership of the original instrumental composition.
